1. Road Access and Constraints

- The Logistics Cluster received reports on the morning of 17 June that the road to Mucojo is open. The Logistics Cluster is verifying this information and will share confirmation with partners as soon as it is received.
- Meanwhile, the Logistics Cluster is working with WFP to assess available transporters to consolidate them in a list and share it with partners.

2. Common Services Updates

- Partners informed the Logistics Cluster that there were no transport nor storage gaps in Pemba.

Air Operations

- The Mi8 stopped operations on 14 June as planned. However, in light of the inaccessibility of Mucojo, funding was made available to extend another helicopter for one to two weeks. In the coming days, the Logistics Cluster will inform partners of the operational details accordingly.

Sea Operations

- The contract is being finalized for the boat for cargo movement from Pemba to Mucojo (capacity of 40 mt). The Logistics Cluster will inform partners as soon as the boat becomes operational.

Storage

- While a Mobile Storage Unit was set up in Ibo, no storage requests were received. Partners confirmed that there are no storage needs on the island as distributions have already been completed.

- In Pemba, partners agreed that commercial options are now available for storage space. The Logistics Cluster communicated to partners that, with commercial solutions available, the warehouse will either be closed or handed over to interested partners. The common storage will be available until end of June.
 - Common storage space is still available in Mucojo and Macamia. As these locations might be needed in July for distributions the Logistic Cluster will maintain them until July and then they could potentially be handed over to partners for management.

3. Gaps and Needs Analysis

- As the pace of the operation decreases, partners were informed that the Logistics Cluster will carry out an exercise on gaps and needs to help define an exit strategy. This exercise will consist in a one-hour interview to identify gaps, constraints and needs with the perspective of shifting into preparedness activities.

4. Partner Updates

- UNFPA reported that their dignity kits need to be transported to Macomia, and Clean Delivery kits will need to be delivered to Mucojo as soon as possible.
- IOM, UNICEF and Nema Foundation are planning distributions in the Olumboa and Quirimize areas. A boat will be loaded in Pemba, while the staff will travel with a speedboat from Ibo to carry the distributions in one day.

The next Logistics Cluster coordination meeting will be held on 24 June at 16:00 at the INGC Compound.
