China	Hong Kong		(Hong Kong SAR) The Government today (November 11) announced the introduction of "Return2hk - Travel Scheme for Hong Kong Residents returning from Guangdong Province or Macao without being subject to quarantine under the Compulsory Quarantine of Certain Persons Arriving at Hong Kong Regulation (Cap. 599C)" (Return2hk Scheme). Starting from November 23 (Monday), Hong Kong residents who, upon fulfillment of the conditions specified under sections 12(2) and 12A of the Regulation, including not having been to places other than Hong Kong, Guangdong Province or Macao in the past 14 days, could be exempted from the 14-day compulsory quarantine requirement when they return to Hong Kong under the Return2hk Scheme. A daily quota of 3 000 has been set for the Shenzhen Bay Port, while that for the Hong Kong-Zhuhai-Macao Bridge (HZMB) Hong Kong Port is 2 000. China	Hong Kong		(Hong Kong SAR) The Governments of Hong Kong and Singapore today (November 11) announced the detailed arrangements of the bilateral Air Travel Bubble (ATB), with designated flights to be launched on November 22. Under the ATB arrangement, travellers between the two places will not be subject to any quarantine arrangements upon arrival, nor restrictions to their travel purposes or itineraries on the condition that they comply with a set of anti-epidemic protocols: ATB travellers must have tested negative in mutually recognised tests taken within 72 hours before their departure. They must also have no travel history to any places other than Singapore or Hong Kong in the last 14 days prior to their departure. The ATB travellers must travel on designated flights to minimise risks. The number of designated flights arriving at Hong Kong will increase progressively, from one flight per day in the first 15 days to two flights per day thereafter depending on the actual implementation. Each designated flight can carry a maximum of 200 ATB travellers. All ATB travellers must undertake COVID-19 tests again via a designated lane at the airport upon arrival at Hong Kong, and then wait at a restricted area of the airport until the receipt of negative test results. ATB to be instantly and flexibly adjusted depending on the epidemic situation of both places and travellers' demands. In short, if the seven-day moving average of the daily number of unlinked local COVID-19 cases is more than five for either Singapore or Hong Kong, the ATB arrangement will be suspended for two weeks. If the relevant figure reported on the last day of the suspension period does not exceed the specified threshold of five, the ATB arrangement can resume. China	All airports		China is temporarily suspending the entry of nationals from the UK, Belgium, France, Russia, Italy, Ukraine, Ethiopia, Bangladesh, and the Philippines, including visa or residence permit holders, citing the COVID-19 pandemic. The announcement was made separately by the Chinese diplomatic missions in the four countries on Thursday. China is also temporarily suspending the entry of foreign nationals living in India, including holders of valid Chinese visas or residence permits. China has also suspended all flights from India. The Chinese Foreign Ministry statement said: "Foreigners holding Chinese diplomatic, service, courtesy and C visas are not affected. Foreigners with emergency or humanitarian needs to visit China, can submit visa application to the Chinese Embassy/ Consulates in India. The entry into China with visas issued after November 3rd, 2020 is not affected...The Chinese Embassy/Consulates in India will not stamp the Health Declaration Forms for the holders of the above-mentioned categories of visa or residence permits." China	Hong Kong		(Hong Kong SAR) Update: An inbound traveller who, on the day on which the traveller boarded a civil aviation aircraft that arrives at, or is about to arrive at Hong Kong (specified aircraft), or during the 14 days before that day, has stayed in 14 specified places (i.e. Bangladesh, Belgium, Ethiopia, France, India, Indonesia, Kazakhstan, Nepal, Pakistan, the Philippines, Russia, South Africa, the United Kingdom, the United States of America, and Turkey), must provide the following documents: 1. the test report in English or Chinese issued by a laboratory or healthcare institution bearing the name of the relevant traveller identical to that in his/her valid travel document to show that: a. the relevant traveller underwent a nucleic acid test for COVID-19, the sample for which was taken from the relevant traveller within 72 hours before the scheduled time of departure of the specified aircraft; b. the test conducted on the sample is a nucleic acid test for COVID-19; and c. the result of the test is the relevant traveller was tested negative for COVID-19; and 2. if the relevant report is not in English or Chinese or does not contain all of the aforementioned information, a written confirmation in English or Chinese issued by the laboratory or healthcare institution bearing the name of the relevant traveller identical to that in his/her valid travel document, setting out all of the aforementioned information and presented together with the test report; and 3. documentary proof in English or Chinese to show that the laboratory or healthcare institution is ISO 15189 accredited or is recognised or approved by the relevant authority of the government of the place in which the laboratory or healthcare institution is located; and 4. the relevant traveller has confirmation in English or Chinese of room reservation in a hotel in Hong Kong for not less than 14 days starting on the day of the arrival of the relevant traveller in Hong Kong. China	Hong Kong		(Hong Kong SAR) Hong Kong and Singapore have reached an in-principle agreement to establish a bilateral Air Travel Bubble (ATB) on October 14. The key features of the ATB are as follows: (a) there are no restrictions on travel purpose; (b) travellers under the ATB will be subject to mutually recognised COVID-19 polymerase chain reaction tests and would need to have negative test results; (c) travellers under the ATB will not be subject to any quarantine or Stay-Home Notice requirements, or a controlled itinerary; (d) travellers under the ATB will be required to travel on dedicated flights, i.e. these flights will only serve ATB travellers and no transit passengers or non-ATB travellers will be allowed on board; and (e) the ATB can be scaled by adjusting the number of dedicated flights upwards or downwards, or even suspended, in line with the latest developments and COVID-19 situation in the two cities. China	All airports		According to a statement released by the Ministry of Foreign Affairs and the National Immigration Administration on Wednesday, foreign nationals holding valid Chinese residence permits for work, personal matters, and reunion can enter China without applying for new visas – effective from 0 am, September 28, 2020. If these 3 categories of residence permits as held by foreign nationals have expired (in the time since the travel ban was imposed on March 28, 2020) – the holders may apply for relevant visas by presenting the expired residence permits and relevant material to the Chinese embassies or consulates on the condition that the purpose of the holder's visit to China remains unchanged (see here). All other measures in the March 26 Announcement by the Ministry of Foreign Affairs and the National Immigration Administration on the Temporary Suspension of Entry by Foreign Nationals Holding Valid Chinese Visas or Residence Permits (see here) will continue to be implemented. China	All airports		Air Crew: the testing and self-isolation arrangement of air crew who arrive at Hong Kong via Airport The first thing is to identify the air crew members as local-based or non-local based crew. Airlines should provide each air crew member a letter certifying whether he/she is a local or non-local based crew. Those who do not possess the airline certification letter will be regarded as non-local based crew. For local based crew, they should proceed to Department of Health (DH)'s Temporary Specimen Collection Centre (TSCC) for collection of deep throat saliva sample and then they can leave for their accommodation agreed by the airline for self-isolation. They should self-isolate for 48 hours or until the next flight, whichever is earlier. Non-local based crew are recommended to possess a negative result of SARS-CoV-2 nucleic acid test done at an ISO15189-accredited laboratory or a laboratory recognized by the Government where the laboratory is located with the specimen collected within 48 hours prior to boarding the flight to Hong Kong for duty (i.e. a pre-departure negative result). The airline should declare on a letter of certification that the crew member concerned has been tested negative. Upon arrival at Hong Kong, all air crew members (no matter local or non-local based) must also submit a deep throat saliva specimen at the TSCC. For those non-local based crew who possess a pre-departure negative result and a certification letter issued by the airline, they can leave for their hotel for self-isolation after specimen collection and no need to wait for the result. For those who do NOT possess a pre-departure negative result, they have to wait at DH's TSCC or other location designated by DH until their test results are confirmed negative. Non-local based crew members have to self isolate at the hotel room arranged by the airline until departure from Hong Kong on their next flight. Point-to-point transportation must be arranged by airlines between HKIA/TSCC and their hotels or accommodation. Use of public transport including MTR, Airport Express, and taxi for crew transfer is prohibited. Crew members must wear masks during the entire journey to and from the HKIA/TSCC.
